A complete set of bidding documents may be purchased by interested bidders on the submission of a written application to the above and upon payment of a nonrefundable fee of an amount Rs. 1000/- in the form of CDR in the name of Director General, City District Government Peshawar. These bidding documents can also be downloaded from the official website of City District Government i.e. [www.cdgpeshawar.gov.pk](http://www.cdgpeshawar.gov.pk) or official website of KPPRA Khyber Pakhtunkhwa Peshawar. These bid documents are required to be signed and attached with the letter head of the bidding firm.

3. Single Stage Two Envelope Procedure (KPPRA Rules) is to be followed for submission of the bid. The bid shall comprise a single package / main envelope containing two separate envelopes consisting of financial proposal and the technical proposal including the bid documents.
4. Technical and Financial Proposals are to be filled separately in column wise order according to the pattern suggested in "Detailed Specification Documents".
5. Only those firms who qualify technical evaluation will be allowed to be considered in financial evaluation. Delivery and installation to be completed within 45 days after issuance of the purchase order.
6. All bidders must submit 2% CDR of the contract value as earnest money in the name of Assistant Director LG & RDD Peshawar. The earnest money of successful bidder will be returned after expiry of warranty period of one year.
7. Deadline for the submission of the bids is 18<sup>th</sup> December, 2020 and should reach before 11:30am while the opening date and time of the bid is 18<sup>th</sup> December, 2020 at 1:00pm on the given date at Office of the Assistant Director (IT) City District Government Bacha Khan Chowk Peshawar.
8. The bidder should have similar experience and should have executed at least three similar projects in reputed organization in the last three years.
9. Bid documents and original call deposit's received through fax or by hand will not be acceptable. Sealed bids sent through registered mail/courier service should reach up to the specified time and date as mentioned above.
10. The eligible bidder must have the relevant codes for the above mentioned works as per Pakistan Engineering Council criteria.
11. Any bidder who provide false, or materially inaccurate or incomplete documents will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43).
12. The PEC and KPRA registration (Active Tax Payer) must be valid for current Financial Year and attached with the tender documents.
13. Any addition made in the terms & conditions in the NIT advertised will be implemented as per KPPRA Rules.
